

**Security State Bank Greater REWARDS Cash & Car Giveaway  
Official Rules**

**INTERNATIONAL TRANSACTIONS ARE NOT ELIGIBLE FOR AUTOMATIC ENTRY. ENTRANTS WAIVE THE ABILITY TO BRING CLAIMS IN A CLASS ACTION FORMAT.**

All entries, whether submitted by using a Security State Bank Mastercard® as described below, a valid check from a Security State Bank Checking Account, or by mail, have an equal chance of winning. For the purpose of this Sweepstakes, Mastercard use includes purchase transactions initiated by a Security State Bank Mastercard only, as more particularly described below.

**Eligibility:** The Security State Bank Greater REWARDS Cash & Car Giveaway (“**Sweepstakes**”) is open only to permanent legal residents of Kansas, who are eighteen (18) years of age or older, as of 4/1/2019. Employees, officers and directors of Security State Bank (“**Sponsor**”); Mastercard International Incorporated (“**Mastercard**”), teamDigital Promotions, Inc. (“**Administrator**”); and each of their respective parent companies, affiliates, distributors, subsidiaries, prize providers, advertising/promotion agencies and the immediate family members (i.e., spouses, parents, children, and siblings and their respective spouses) and/or those living in the same household of any of the foregoing are not eligible to enter or win. Sponsor, Security State Bank, Administrator, and each of their respective parent companies, affiliates, distributors, subsidiaries, prize providers, and advertising/promotion agencies are each a “**Released Party**” and shall hereinafter collectively be referred to as the “**Released Parties**”.

**Promotion Period:** Sweepstakes begins at 12:00:01AM Central Time (“**CT**”) on 4/1/19 and ends at 11:59:59PM CT on 3/31/20 (“**Promotion Period**”) & consists of four (4) entry periods (each an “**Entry Period**”) as outlined below.

**How to Enter:** There are three (3) methods of entry: 1) **To enter the Sweepstakes using your Security State Bank Mastercard (“Card”)** – you will automatically receive one (1) entry into the Sweepstakes each time you use your Card to make an eligible purchase transaction in the amount of \$25.00 or more during the Promotion Period. Purchase transactions involving international transactions, account adjustment transactions/returns, late payment fees, over-limit or over-draft fees, ATM fees, cash advances, monthly/annual fees, balance transfers and/or other fees assessed on your account are not eligible for automatic Sweepstakes entry. Entries from unauthorized Card use or made with lost, stolen, or fraudulent Cards are void. Only purchases made with a Card in good standing (both at time of entry and winner selection) and issued by Security State Bank to an identifiable cardholder (as set forth herein) and that are processed and submitted through Mastercard International Incorporated’s U.S. transaction processing system during the Promotion Period are eligible for automatic entry; or 2) **To enter the Sweepstakes using your Security State Bank Checking Account Checks (“Check”)-** you will automatically receive one (1) entry into the Sweepstakes each time a valid Security State Bank Check posts to your account, in the amount of \$25.00 or more, from your Security State Bank Checking Account during the Promotion Period. Check transactions involving over-limit or over-draft fees, return check fees, and check re-order fees are not eligible for automatic Sweepstakes entry.; or 3) **To enter without using a Card or Check** - you may receive one (1) entry by hand printing your full name,

complete mailing address, telephone number, date of birth & the words "Security State Bank Greater REWARDS Cash & Car Giveaway Entry" on a plain 3" x 5" piece of paper & mailing it in a sealed, stamped & hand printed #10 envelope to: Security State Bank Greater REWARDS Cash & Car Giveaway Entry, P.O. Box 170, Scott City, Kansas 67871. Enter as often as you wish by mail, but each entry must be mailed separately, postmarked by the applicable postmark deadline & received by the applicable mail-in deadline (set forth below). There is no limit to the number of entries an eligible consumer may receive during the Promotion Period, regardless of entry method. No photocopied, computer generated facsimiles, mechanically reproduced, or mass entries permitted. All entries become property of Sponsor and will not be returned. Released Parties are not responsible for lost, incomplete, illegible, late, misdirected, stolen, postage-due, or mutilated entries or mail; any error, omission, interruption, defect or delay in transmission, 3<sup>rd</sup> party transaction classification, transaction processing, check processing, or communication; technical or mechanical malfunctions; failures or malfunctions of phones, phone lines, or telephone systems; errors in these Official Rules, in any Sweepstakes-related advertisements or other materials; human-processing error; failures of electronic equipment, computer hardware or software; or inaccurate entry information, whether caused by equipment, programming used in this Sweepstakes, human error, or otherwise. Sponsor reserves the right, in its sole discretion, to void any and all entries of an entrant who Sponsor believes has attempted to tamper with or impair the administration, security, fairness or proper play of this Sweepstakes.

**Winner Selection:** At the conclusion of each Entry Period, four (4) First Prize winners will be selected in individual random drawings from among all eligible entries received for the applicable drawing, for a total of four (4) First Prize drawings. At the conclusion of the Promotion Period, one (1) Grand Prize winner will be selected in a random drawing from among all eligible entries received for the duration of the Promotion Period. All drawings will be conducted by Administrator, an independent judging organization, whose decisions will be final & binding in all matters relating to this Sweepstakes. **Non-winning entries received for one Entry Period drawing will not carry forward to subsequent Entry Period drawings.** The potential prize winners will be notified by Sponsor by telephone, email and/or mail (method selected in Sponsor's discretion). In the event that a potential winner is selected via a Card or Check transaction, prize will be awarded to the primary account holder (as determined by Sponsor's account records & subject to the timely identification of the account holder) named on the account accessed by the Card used to make the entry &, in the event that a small business Card or checking account is selected, prize will be awarded to the individual named on the Card or checking account that is used to transact the winning entry (as determined by Sponsor's account records & subject to the timely identification of the individual named on the applicable Card). If awarding of a prize is in conflict with the business' written policy or not feasible after Sponsor's good faith effort to obtain account holder contact information, prize will be forfeited & an alternate winner may be selected. Odds of winning will depend on the total number of eligible entries received.

**Prizes: One (1) Grand Prize and Sixteen (16) First Prizes will be awarded.** Limit one (1) First Prize per person, immediate family member or household. Federal, state, and local taxes and all other expenses not specified herein are each winner's sole responsibility. The Approximate Retail Value ("ARV") of the Grand Prize is based on available information provided to Sponsor and the value of any prize awarded to a winner may be reported for tax purposes as required by law. Winners may be required to provide Sponsor with a valid Social Security number before any prize is awarded for tax reporting purposes. An IRS Form 1099 may be issued in the name of each winner for the actual value of the prize received. Unclaimed prizes will be forfeited.

Sponsor and Administrator additionally reserve the right, in their sole and absolute discretion: (a) to modify, suspend or terminate the Sweepstakes should causes beyond Sponsor's or Administrator's control corrupt or interfere with the administration, integrity, operation, security or proper play of the Sweepstakes; or (b) to disqualify any entrant found to be, or suspected of: (i) tampering with the entry process or the operation of the Sweepstakes; (ii) acting in violation of these Official Rules; or (iii) acting in an un-sportsmanlike manner. CAUTION: Any attempt to undermine the legitimate operation of this Sweepstakes is a violation of criminal and civil laws and should such an attempt be made, the Sponsor and the applicable Released Parties reserve the right to seek damages (including attorneys' fees) and/or other remedies from any such person(s) responsible for the attempt to the fullest extent permitted by law. In the event that any provision of the Official Rules is determined to be invalid or otherwise unenforceable or illegal, the other provisions will remain in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Headings are solely for convenience of reference and will not be deemed to affect in any manner the meaning or intent of the documents or any provision hereof.
